<b>3. Purpose and legal basis of the processing</b>	We process your personal data sent to us in connection with the use of our contact form exclusively to reply to your questions or comments, and possibly with the objective of entering into a business relationship. The legal basis is Art. 6 subsection 1 sentence 1 (b) DSGVO.  If the enquiry does not have the purpose of initiating a business relationship, the data processing is performed for the purpose of legitimate interests in accordance with Art. 6 subsection 1 (f) DSGVO. Our interest is in responding to your questions or comments.  If we have received your consent for the processing of your personal data for specific purposes, the processing of this data is done on the basis of Art. 6 subsection 1 (a) DSGVO.
<b>4. Recipient of the personal data</b>	If necessary for responding to your enquiry, your enquiry may be passed on within our group of companies Only those parties who need the data for performance of the above referenced purposes receive access to your data.
<b>5. Duration of storage of personal data</b>	Your data are processed at the time they are collected and are erased 6 months after the transaction. In the event that you have consented to further storage of your personal data, we will erase the data at a later time.

<b>6. Rights of data subjects</b>	You have the following rights in accordance with Art. 12 to 23 DSGVO if the statutory requirements are fulfilled:  At all times you have the right to demand access (Art. 15 DSGVO), rectification (Art. 16 DSGVO), erasure (Art. 17 DSGVO) or portability of your data (Art. 20 DSGVO) if the statutory requirements have been fulfilled. In addition, you have the right to restrict processing (Art. 18 DSGVO). If you are not in agreement with the nature and manner of the data processing, you have the right to lodge a complaint at all times with the supervisory authority competent for us (Bayerisches Landesamt für Datenschutzaufsicht) (Art. 77 DSGVO).
<b>7. Right to revoke consent</b>	If you have consented to processing via a (later) declaration, you can revoke your consent at any time in the future. We will then no longer process your personal data in the future for the purpose for which it was collected. You can send the revocation at any time to our contact point.
<b>8. Transfer to third countries outside the EU</b>	Your data will not be sent to third countries outside the EU.
<b>9. Automated decision making and profiling</b>	Automated decision making including profiling within the meaning of Art. 22 subsections 1-4 DSGVO does not take place.
