REACH Declaration

Dear Customer,

REACH is the new European chemicals legislation that entered into force on July 1, 2007. It acts as a registration, evaluation, authorisation and restriction of chemicals.

The Baumüller Nürnberg GmbH, all of the fully owned subsidiaries are downstream supply chains within the meaning of REACH. We neither produce nor import substances and preparations related to REACH. Therefore, we are not subject to a compulsory registration and must not prepare safety data sheets.


The Baumüller Nürnberg GmbH is aware of the responsibility within the supply chain and complies with the demanded REACH-standards. All products of Baumüller Nürnberg GmbH supplied to you are classified products referring to the REACH-regulation (Art. 3, definition) and consequently are not subject to compulsory registration. Our supplied products do not release substances pursuant to the REACH-regulation, article 7 under normal or reasonably foreseeable intended use and are not relevant in our view.

We assure to follow up and compare the substance information in the REACH annex with the updates of the REACH demands especially the enlargement of the list of candidates as well as the inclusion of substances (Candidate List of Substances of Very High Concern for Authorisation, REACH-Annex XIV).


On behalf of a maximum product safety we watch the implementation of the REACH-regulation at our suppliers and according to the REACH-regulation, article 33 we have asked them to immediately inform us, if by ECHA now or in future there ought to be substances of very high concern with more than 0.1 mass percent in the product. As soon as the manufacturer forwards the relevant information in this to us, we will immediately and unrequested forward the information to you.

We will furthermore inform you about relevant changes within the products, their delivery capacity as well as the quality of the supplied parts/products within the scope of our business relationship and in individual cases we will come to an agreement about appropriate steps. Our declarations refer solely to the current knowledge and are based on information of our suppliers. For circumstances beyond our knowledge and control we assume no warranty and no liability.
